NCARB VISITING TEAM

MCKINNEY, WARD, ARMSTRONG & HILLEGAS

DISCUSSION	NCARB President Dale McKinney and 1 st VP President Elect Dennis Ward joined the meeting to answer any questions Region 6 had regarding NCARB's programs and draft Resolutions. Mike Armstrong, NCARB CEO and Kathy Hillegas, Director of Council Relations also were in attendance.
<p>Tian Feng, CA remarked that there were a lot of changes and initiatives going on with the Council and asked if this was normal. McKinney remarked that is somewhat normal, but the Council was looking to get some of the new initiatives in place and then take a breath to let everyone get used to all the changes. George Garlock, NV noted Armstrong had been doing a tremendous amount of travel attending jurisdictional board meetings and asked if the Council had developed a paper on Best Practices that could be shared with the member boards? Armstrong said that the Council had not developed a paper on Best Practices and remarked that each member board was unique.</p> <p>Chair Oschwald thanked the Visiting Team for stopping by to visit.</p>	

REGIONAL DIRECTOR'S REPORT

BOB CALVANI

Discussion	Regional Director Bob Calvani gave the following report:
<p>Bob welcomed everyone to New Orleans. The Council has been working on a lot of different initiatives in the past year, including:</p> <ul style="list-style-type: none"> • Title Task Force – put together to study the use of the title "intern" and give a recommendation to the Board of Directors for consideration. The names of the Intern Advisory Committee (IAC) and the Intern Committee (IC) will be affected. • IDP Streamline – is progressing along and will be implemented on July 1, 2015. To date, 41 jurisdictions have indicated they will implement it. The proposal will reduce the current 5,600 hours to 3,740. 	

- The IDP Overhaul was briefly discussed. The 17 experience areas will be narrowed down to 6, and will follow the categories for the Architect Registration Examination (ARE) 5.0.
- The proposed Broadly Experienced Architect (BEA) program changes were also discussed. This is a complicated issue and many jurisdictions are for and against the proposal as written and presented to the Council membership. This matter will warrant further discussion from a regional level because the state registration laws are very diverse in our region.
- The proposed resolution for the Broadly Experienced Foreign Architect was discussed. New changes to the program include: must have a recognized education credential, and it must be in a country with formal recordkeeping for disciplinary actions, must complete IDP and pass the ARE.
- Regional Strategies: Bob urged the Region to continue to develop future leaders. When candidates from Region 6 identified themselves as being interested in serving the Region or the National Council, please support them however possible.
- NCARB released the RFI and RFP on June 1, 2015 regarding school interested in participating in the pilot program regarding the Integrated Path to Licensure. 32 schools have expressed interest in the program.
- Calvani asked the membership to please make sure to participate in the Annual Member Board Survey from NCARB. This informs the Council how to continually improve its services, meeting quality, volunteer experiences, legislative assistance and continue to provide support to boards, jurisdictions, legislature, architects and candidates.
- Branding continues to be a main focus of NCARB Board of Directors. Value of the NCARB certificate needs to continue to be elevated and recognized. Some of the benefits certificate holders get include one free mini-monograph each month for a total of 12/year, e-monographs, alternatives to the certificate (BEA, BEFA).
- Fee restructuring for the IDP will be \$100/year application fee initially, then \$85 yearly; the ARE will cost \$210 for 2 years and then will increase an additional \$20 per division. The costs to take the entire ARE will be \$1,410 (\$235x6).
- Future meetings will be: Regional Summit in March 2016 in Savannah, GA and next year's NCARB ABM will be in Seattle, WA.
- Calvani thanked the membership for the opportunity to serve as the Regional Director and said that he is looking forward to serving the Region in the coming year.

REGIONAL CHAIR'S REPORT

DISCUSSION	<p>Oschwald reported that the Regional Summit in Long Beach, hosted by Region 6, was a very successful, well attended meeting. The Region, especially the Executive Committee, enjoyed hosting the Summit for all six regions of NCARB.</p> <p>He said that in the coming year, the Executive Committee and its various committees will be working on the white paper discussing the benefits of regional membership. A website committee was formed to work on the branding and look for the new WCARB website, which will hopefully be ready to launch at the Regional Summit next March. He asked the members to share any potential branding ideas with Hans Hoffman or Gina Spaulding.</p> <p>Oschwald thanks the membership for the opportunity to serve as the Regional Chair.</p>

Just completed an extensive overhaul of the residential designer's examination, which is a regulated profession unique to Nevada. The Nevada board writes the residential design examination.</p> <p>Oregon: Has yet to decide whether to accept streamlined IDP in state.</p> <p>Washington: Also still deciding whether or not to accept the streamlined IDP.</p>

FINANCIAL REPORT

JON BAKER

DISCUSSION

Jon Baker gave the WCARB Region 6 financial report:

Regarding the Region's current financial position:

- The 2014-2015 budget previously approved by the membership in June 2014 for the fiscal period of October 1, 2014 - September 30, 2015 was provided for review and information purposes. Also provided was a copy of last year's budget for comparison and information purposes. A copy of the 2014-2015 budget has been appended to this document as **Appendix "B."**
- The Balance Sheet through June 15, 2015 was provided in the agenda packet for the membership. This statement is appended to the end of this document as **Appendix "C."** The Profit and Loss statement for October 1, 2014 through June 15, 2015 was also provided and is appended to this document as **Appendix "D."** The Profit and Loss statement for the previous fiscal year of October 2013 through September 30, 2014 was provided and is appended to this document as **Appendix "E."**
- As of June 15, 2015, total assets from both the checking and savings account total \$168,279.67. The region is in good financial shape.

REVIEW AND APPROVAL OF THE 2015-2016 WCARB BUDGET

Baker went through the draft budget with the membership. This year's budget provides for a new computer, printer and software for the WCARB office. The last computer for the WCARB office was purchased in 2009 and is on it's last legs. Also included in the budget is \$1000 for the design of a new website for the region. The old website is outdated and no longer supported by web.com. Baker told the membership that it is possible the website design may cost more than \$1000. Arizona requested that if the website budget exceeds \$1000 that it be paid for with the region's reserves.

Motion to approve the 2015-2016 WCARB Budget by Tara Rothwell-Clark (NM), seconded by: Neitha Wilkey (WA). Vote: Passed.

REVIEW AND DECISION WHETHER TO AMEND WCARB RULES

At the March 2015 Regional Summit, the Region reviewed a proposed bylaw change to establish a policy to amend section 7.5 of the WCARB Rules to allow unused travel funds to remain in the member jurisdiction's travel account until it is used.

The new language for Section 7.5 will read as follows:

"7.5 Supplemental dues for delegate travel expenses to a WCARB meeting that have not been requested for reimbursement shall remain in the Member jurisdiction's travel account."

Motion to approve by Bert Yumol (HI), seconded by Mark Ruth (GU). Vote: Passed.

NCARB 2015 RESOLUTIONS DISCUSSION

JIM OSCHWALD

Chair Oschwald asked if anyone wished to discuss the draft resolutions:

Doug Sams, Chair of the Oregon Board, presented an amendment to the NCARB draft resolution 2015-1 (BEA) and 2015-2 (BEFA). Oregon wants to amend the resolutions to strike the 2x IDP, 5x IDP and replace it with "must complete one additional cycle of IDP." A lengthy discussion ensued within the region about the proposal. Oregon will work with NCARB to submit its changes before the council membership votes on the resolutions.

Chair Oschwald told the membership that next year's Regional Summit would be hosted by Region 3 and will be held in Savannah, GA on March 11-12, 2015. Additional information regarding the Regional Summit will be sent out to the membership sometime in December 2015.

Resolved, Revisions to the Intern Development Program Requirements and Guidelines may only be effective upon a majority vote of the Member Boards.

SPONSORS' STATEMENT OF SUPPORT:

The Oregon State Board of Architect Examiners recommends that the IDP objectives and the specific requirements for achieving those objectives should be the responsibility of the Member Boards that must administer the licensing process within their jurisdictions. We acknowledge wholeheartedly the incredible contribution of the NCARB Council Board of Directors and NCARB staff that research, develop, and recommend revisions to members and look forward to that collaboration in the future. However, we believe the ultimate responsibility to adopt and implement these changes lies with the Member Boards and not with the Council Board of Directors. The Statement of Support in 2009 noted "Like the ARE, the IDP should be promptly updated and revised as architectural practice changes over time and should not await action at the Annual Meeting". However, actions since have shown that time is not of the essence and revisions to both the ARE and IDP can await the needed discussion, debate, and revisions that the Member Boards bring to the regional and annual meetings. Therefore, we recommend that this resolution be effective as of June 30, 2016.

Brief Overview of Current Issues

The Arizona Board is up for Sunset this legislative session. The Committee of Reference recommended that the Board be continued for another 8 years. The Continuation bill and an Omnibus bill are pending in the Arizona House of Representatives.

The biggest challenge to the Arizona Board to date has been the legislatively proposed deregulation of geologists and landscape architects (along with yoga instructors, fruit pickers and driving school instructors!); a push being championed by Arizona's new governor. To date, the Governor has agreed to pull landscape architects out of the bill and we hope that he will agree to remove geologists as well. The Governor's Office staff indicated an interest in deregulating all the design professions in Arizona and stated that the Board is "too autonomous."

Current Legislation Related to Architecture

The Arizona Board's Omnibus bill proposes to make the definition of "architect" more clear; indicating that only those registered as an architect by the Board can call themselves an "architect." The bill also redefines "Record Documents" to include "as-constructed" or "as-built" plans.

Brief Overview of Current Issues

NCARB Integrated Path Initiative (IPI) The Board has been highly interested in NCARB's work to support schools seeking to implement an integrated path to licensure within academic programs. Three of the NCARB-accepted programs are from California (NewSchool of Architecture and Design, University of Southern California, and Woodbury University). To facilitate the efforts of the schools, the Board amended its Sunset Review bill with language that would enable candidates enrolled in an Integrated Path Initiative program early eligibility to take the ARE. The Governor signed AB 177 on October 2, 2015. In addition, the three California schools attended the Board's March 3, 2016 meeting and provided overviews of their programs so opportunities to collaborate can be identified.

Intern Title The Board's Strategic Plan contains an objective to monitor the NCARB Future Title Task Force. Prior to the Task Force releasing its findings, AIA - California Council proposed amending the Practice Act to create a title to "provide a means with which to formally recognize those committed to becoming California licensed architects." The Board has reviewed the AIACC proposal and concluded it is insufficient to make a determination on the value of creating a title for candidates. The Board will consider the matter further upon submittal of a comprehensive proposal.

California Supplemental Examination The Board typically conducts an Occupational Analysis (OA) every five to seven years by surveying practitioners to determine the necessary knowledge, skills, and abilities to perform architectural services with minimum competency. The Department of Consumer Affairs Office of Professional Examination Services (OPES) began the process by conducting focus group meetings with stakeholders in related professions and architects. OPES analyzed the results from the meetings, which were then used to inform the development process of the OA questionnaire.

The OA questionnaire was distributed to a representative sample of California licensees in early July 2014. Results from the survey were reviewed by OPES and analyzed by subject matter experts with the findings presented to the Board. OPES completed the ARE review and linkage study that compared the content of the CSE Test Plan with the subject matter covered in the various divisions of ARE 4.0 and 5.0 in order to ensure there is minimal overlap in the content of the CSE. The final step, completed July 2015, was reclassification of the CSE item bank to align it with the new CSE Test Plan. Development of the CSE based upon the new test plan is planned to commence in late 2016.

The Board is considering changes to its rules for reciprocity to allow those without an NCARB certificate to apply for licensure under a “Broadly Experienced Architect” process.

In the past year, the Board helped successfully advocate for changes to the application of the New Mexico State Use Act, which was intended to assist people with disabilities to access employment opportunities in state government outside of a competitive environment. Prior to the change, implementation of the Act entailed allowing a nonprofit organization to offer architectural services, pursue contracts and provide assistance to a few architects who had qualified under the Act as persons with disabilities. BRIEF OVERVIEW OF CURRENT ISSUES:

After a year of research and discussion, the board adopted a policy regarding time requirements for the Intern Development Program as follows:

The architect licensing law in Washington requires applicants have at least three year's practical work experience in a structured intern development program approved by the Washington Board for Architects. RCW 18.08.350(3)(a). The Board requires interns to be enrolled in NCARB's Intern Development Program for a minimum of 5,600 hours. Interns who complete their IDP core hours in less than three (3) years must continue to work under the supervision of an IDP Supervisor until they have completed a total of 5,600 supervised IDP hours.

MISCELLANEOUS:

The board continued its outreach efforts by meeting in different regions around the state as well as meeting on university campuses. Board members met with architecture students at Washington State University which is one of two NAAB accredited degree programs in the state. They also met at Lake Washington Institute of Technology where they interacted with students and heard from a past graduate who recently finished the ARE and received his license.

Upgrades were made to the on-line licensing renewal system to allow licensees to create their own password, and future upgrades are being developed to allow future candidates for licensure to submit applications including all documentation on line.

The board remains committed to providing exam candidates and licensees friendly and efficient procedures and services, communicating with licensees (via our web site and listserv) and listening to concerns, pursuing disciplinary cases, and supporting laws which protect the health, safety, and welfare of Washington citizens. The board's listserv grew to 1,010 members in 2015.

Benefits of Regional Membership

Why: Evaluate the need for regional structure, meetings, and dues.

Facts: The Western Council of Architectural Registration Boards (WCARB) was the first regulatory organization of architectural licensing jurisdictions. Through this legacy, the WCARB Executive Committee has been a leading advocate for the member jurisdictions within the region.

Regional Structure

Regional structure recognizes the uniqueness of practice and regulation amongst different areas of the country and provides for collective input on national issues. It is the responsibility of each member board to stay abreast of national changes that could affect its jurisdiction and the region as a whole. ***At a time when change is happening more quickly than ever, it is imperative that the regional structure remain as it is today.***

The current regional structure:

- Recognizes the individual uniqueness of regional architectural practices and conditions.
- Provides regional representation on the Board of Directors for the National Council of Architectural Registration Boards.
- Supports leadership development within the region for future positions on the WCARB Executive Committee and the Board of Directors for the National Council of Architectural Registration Boards. A major benefit to member boards is having member-board members within the region involved in the national governance structure, as it provides invaluable knowledge of NCARB's major initiatives, programmatic changes, and especially in assuring that NCARB is sensitive to the concerns of the individual states.
- Provides education and communication opportunities for member-board members within the region, thereby strengthening the member boards individually and the regulation of the practice as a whole.

Regional Meetings

Regional meetings among jurisdictions provide for more in-depth discussions on relevant issues facing the profession and for regulation of the licensing process in a smaller setting, with opportunities for collective input from a regional perspective.

The current regional meetings:

- Provide regional interaction and a platform to share solutions.
- Assist in achieving effective regulation and enforcement.
- Support the sharing of best practices, successes, and concerns among member boards.
- Offer an opportunity for member boards to be better informed and to have questions answered.
- Provide regional evaluation of national trends and NCARB proposals.

- Facilitate a regional review and vetting of regulatory changes.
- Allow for the opportunity to share information pertaining to candidate credentials and disciplinary information.
- Provide for the development of strategic initiatives and policy positions to benefit the region.
- Provide a manageable forum that promotes open discussion and representation of individual member boards when reviewing NCARB proposals, resolutions, and other issues facing the membership.

Regional Dues

If the value of the regional structure and regional meetings to the member boards is confirmed, then the cost of administering the program should continue to be supported through a reasonable and defensible dues structure.



All,

Thirty five years ago NCARB's significance to me was as a vehicle to facilitate licensure through reciprocity in states where our clients were expanding their businesses. I became a Certificate Holder with no other expectations than that one goal. Since those early practice years, the Council has flowered into a foundation organization that underpins all that is critical to our profession's existence. Today, the Council touches us beginning with high school graduation, continuing through college, licensure and on to regulating our practice as licensed professionals, a lifetime impact. Today, the Council is the controlling agency, or plays a significant role in: 1) Intern record establishment and maintenance, 2) development and improvement of the Architecture Experience Program (AXP), 3) development, administering and dissemination of the cyclical Practice Analysis, 4) development, administration and regulation of the ARE, 5) participation in the preparation of NAAB accreditation criteria and participating in accreditations, 6) maintenance and optimization of all Council Records and Certifications, 6) verification and reciprocity facilitation for Certificate Holders, 7) evaluation of non-traditional path Certificate candidates, 8) Member Board assistance and facilitation (transmittal of records, disciplinary monitoring, model law development, legislative assistance, candidate evaluation), 9) regulation representation among our collateral organizations, 10) national representation on international regulatory matters, 11) collection and dissemination of the profession's statistics and, 12) evolution of professional continuing education. This is an important list: For the continuation of our profession, these are not optional activities. All other roles that we play as designers, business people and community members are predicated on the success of NCARB fulfilling these responsibilities; NCARB makes it possible. NCARB, its Member Boards, Staff and Volunteers all have worked hard, in concert, to keep this public protection machine working effectively.

An informal goal of the Board of Directors is to try to maintain continuity and management focus from year to year as Directors and Officers turn over. This encourages the Board to remain focused on issues that by their nature usually span several years and allow Member Boards the time to understand, provide input and decide in an unhurried manner on the Council's direction. I endorse this approach and will continue to work collaboratively with the Board and Staff addressing the Council's challenges.

In the foreseeable future I anticipate the Council will be presented with several significant challenges, some on-going, some new:

Regulation and licensing questioned: With the Supreme Court's North Carolina Board of Dental Examiner's decision, there likely will be efforts in some jurisdictions to revisit professional licensing legislation to reduce perceived regulation. I endorse our current preparatory efforts toward this challenge.

- Expansion of the value of the Certificate:** Working from the feedback from President Ward's charge to each of the committees, there are many quality, actionable ideas that need to be implemented.
- Strategic Plan evaluation and re-assessment:** This working document has served well and is still relevant, however, much has changed since 2010 and its provisions should be re-visited and any gaps addressed.
- Continuing evolution of the path to licensure:** While substantial changes have been made in the eligibility to take the exam, the AXP duration and the structure of the ARE (5.0), the next step is refinement and correction based on the feedback from these changes.
- Member Board interactive services and data base integration:** A major part of the Strategic Plan, this is an on-going refinement and facilitation process that will be undergoing continual change.
- AXP continuing development:** Traditionally, the focus has been on interns; there now needs to be efforts made to improve the program through Mentor training and, possibly credentialing.
- Preparation for the next Practice Analysis:** Drawing from the (positive) experience of the last Practice Analysis, planning needs to start for the next cycle, if only to the extent of evaluating the timing and formulation.
- Evaluation and re-assessment of the NAAB accreditation process:** Concurrent with the potential restructuring of ACSA/NAAB and in the context of the current economic and regulatory climate, the existing accreditation process, team structure and visit schedule(s) should be re-evaluated.
- Expansion and development of international cooperation and regulation:** Tri-lateral discussions with Australia and New Zealand have culminated in a Mutual Recognition Arrangement to be placed before the membership in June. Going forward similar opportunities and arrangements should be pursued; the Certificate is a perfect credential for United States Architects in this context.
- Continuing support of ARE 4.0 and transition to ARE 5.0:** Feedback from ARE 5.0 testing will begin the normal iterative process of test refinement that must always take place with the initial roll out of new exams.

From above, it should be evident that I feel NCARB is probably the most germane of the Architecture related professional organizations. The Council's responsibilities and challenges are significant and form the foundation for the perpetuation of the Profession. I feel that it is critical we maintain momentum on all fronts. The Council is blessed with bright, motivated, intelligent staff, a great CEO and a super important mandate. With these concerns and motivations in mind, I announce my Candidacy for NCARB Second Vice President. I welcome any questions or comments you may have and look forward to discussing these issues in more detail with you at the Regional Summit in March and the National Conference in June.

Region 1 NECARB By-Laws and Policies

ARTICLE VII - EXECUTIVE COMMITTEE, REGIONAL DIRECTOR AND OFFICERS a) EXECUTIVE COMMITTEE: The Executive Committee shall consist of the Chairperson, Vice Chairperson, Secretary-Treasurer and Regional Director. The Executive Committee shall: a. manage, direct and administer the affairs of the Conference b. put into effect all general policies, directives, and instructions adopted at meetings of the Conference c. perform all duties required by these bylaws and the bylaws of NCARB

The purpose of the Spring Meeting shall be to elect the Conference's officers, to select the Conference's nominee for NCARB Regional Director, and to transact any other business, which may properly come before the meeting. The purpose of any special meeting shall be described in the notice of such a meeting.

OFFICERS: The regional officers of the Conference shall be a Chairperson, Vice Chairperson, and Secretary-Treasurer. Any nominee for such office shall be a member of a member board or an incumbent officer at the time of his or her election. In the absence of the Chairperson at a meeting the Vice Chairperson shall serve as a temporary Chairperson. In the event of a vacancy in the office of the Chairperson, the position shall be filled for the balance of the term by the Vice Chairperson. In the event of a vacancy in the office of the Vice Chairperson or the Secretary-Treasurer, the Executive Committee shall fill such position for the balance of the term elected from the Executive Committee.

TERM OF OFFICE: The Chairperson, Vice Chairperson, and Regional Director to NCARB shall be one year. The Regional Director, Chairperson, and Vice Chairperson may be reelected for a maximum of three consecutive years. Secretary-Treasurer shall be elected for a term of one year and may be re-elected for a maximum of five one year terms. Any officer or the Regional Director shall be permitted to complete their term of office if that person's term as a Member Board Member expires before completion of their term. The end of the term for all offices shall be at the close of the NCARB Annual Meeting. The terms for members of the Executive and Nominating Committees shall also end at the close of the Annual Meeting.

Region 4 Election process and Officers' duties as outlined in Article VII of Region 4 Bylaws

(B) The Region shall elect as officers a Chair, a Vice-Chair, and a Secretary/Treasurer by majority ballot at the spring meeting. Any nominee for Chair, Vice-Chair and Secretary/Treasurer shall be a member of their state board at the time of election or an officer of Region 4 in the year immediately preceding the election. Eligibility for election as a regional officer shall extend no more than three years from the end of membership on a state board. The term of office is one year. Terms may be served in succession. The Region shall nominate a regional director by majority ballot at the annual spring meeting. The qualifications of a candidate for election as regional director shall be described in the bylaws of the NCARB.

(C) The Chair shall be the administrative head of the Region. He or she shall perform all the duties required by these bylaws or delegated to him or her by the Executive Committee and all other duties which are usual and incidental to this office. He or she shall preside at every meeting of the Region and the Executive Committee. In the event that the Region's NCARB Regional Director is unable to attend a meeting of the NCARB Board of Directors, the Chair shall have the privilege of participating in such meeting in the Director's stead, unless otherwise provided in the NCARB bylaws.

(D) The Vice-Chair shall assist the Chair in his or her duties. In the absence of the Chair, the Vice-Chair shall act in his or her place with the same authority and duties as if he or she were the Chair. In the absence of both the Chair and the Vice-Chair, the Executive Committee shall elect a temporary chair to preside and perform all the duties as may be properly assigned to him or her by the Executive Committee.

(E) The Secretary/Treasurer shall be responsible for maintaining records, giving notices, and handling financial matters on behalf of the Conference, subject to the direction of the Executive Committee. He or she shall prepare and forward invoices, receive all moneys, and deposit same in the name of the Region in a bank approved by the Executive Committee. He or she may delegate such duties to an Executive Assistant as he or she and the Executive Committee may decide.

(F) The Executive Committee may appoint an Executive Administrator of the Region whose duties shall be assigned by the Conference. He or she shall be paid such salary as determined by the Executive Committee and reimbursed such expenses as approved by the Chair and Secretary/Treasurer.

(G) The Chair of the Region shall make an annual report, in writing, to the annual spring meeting. The report shall describe the activities of the Region since the last meeting.

(H) All officers and members of the Executive Committee shall serve from the adjournment of the NCARB annual meeting and Region immediately following or coinciding with their election until the adjournment of the next NCARB annual meeting and conference, and until a successor is duly elected.



- The Chair, Vice Chair, and Secretary/Treasurer shall be elected, by majority vote of Members present at the Annual Meeting of WCARB, from among the membership of the Executive Committee who will be in office immediately following the adjournment of the next Annual Meeting of NCARB. Their term of office will commence immediately following the next Annual Meeting of NCARB.
- Any candidate running for the Executive Committee shall have the opportunity to address the membership. In the event of a tie in an election for a position on the Executive Committee, the candidate shall have the opportunity to readdress the membership, followed by another caucus of the membership. This process shall repeat until a winner is declared.



Walk past Bowl Street and it's directly across from the Outback Steakhouse. The Stoddard Room is on the 5th floor. You can access it either from their elevator or by taking the stairs.
